If you are operating in a supervisory, management or consultancy capacity then this qualification is for you. Once you have achieved this qualification you will have positioned yourself as an expert in the pest control industry.

#### Course program

The Field Pest Biologist culminates in a Master Pest Control Operator/Manager whose function it would be to set up a full pest control program for a facility. This would entail a full assessment of the site to identify infestation, areas of access and vulnerability where pests might enter and nest in the facility. The field pest biologist would then work out a treatment plan combining all elements of integrated pest management to firstly block entry into the facility, then removing food and water sources and only then implement a treatment program that will use the least amount of pesticides choosing the options that are least toxic with acceptable LD50 values. Monitoring the success of the pest control plan coupled with infestation flow charts will then be the priority to advise the customer on strategies to minimize ongoing infestation.

The program starts with a full day training program where the prospective field pest biologist will be given workbooks, assignments and an outline of the thesis requirements. The learner will then have three months to complete his/her thesis which must be based on real time active facilities where a full case study can be done. The program will then culminate in a final day where the workbooks, assignments and the completed thesis are assessed together with a full practical and problem solving assessment. The prospective field biologist will also be expected to identify a full range of health and nuisance insects during the final assessment.
